### **CANADIAN RESIDENT**

- **Canadian resident returning to  
Canada from abroad**

- **Temporary resident returning to Canada from abroad**
- **Former Canadian resident who is returning to Canada**

## **WHAT**

---

- Goods imported for personal or household use and reported at time of return to Canada.
- Returning from abroad after an absence from Canada + **than 7 days** = Entitled to a personal exemption valued at **max. 750 \$CAN**
- Absence of Canada + **than one consecutive year** = Goods for personal or household use individually valued ≤ **10 000 \$CAN = Duty free**. Article valued at > **10 000 \$CAN** = Duties and taxes apply only to the portion of the value that exceeds 10,000 \$CAN

## **NON-RESIDENT**

---

- **Student**
- **Temporary worker for a period not exceeding 36 months**
- **Seasonal Resident (minimum 36 months - only one importation under this tariff item)**
- **Immigrant**
- **Member of a diplomatic Mission**
- **Visitor (maximum 12 months – Goods must be re-exported at the time of departure)**

## **WHAT**

---

Goods imported for personal or household use in Canada.

## **REQUIRED DOCUMENTS**

---

- List of content (3 copies)
- Photocopy of a valid passport
- Power of Attorney for unaccompanied goods customs cleared by a third party
- **+ Depending on your status :**
- Documentation from Citizenship and Immigration Canada (CIC) (student – worker)
- Study or work permit and letter from the employer (student – worker)
- proof of ownership of a seasonal residence or of a minimum three-year lease (seasonal resident)
- Proof of Immigrant status request in Canada (immigrant)
- Proof of temporary entry authorization (immigrant)
- DFAIT ID Card (Diplomat)

## **RESTRICTIONS**

---

- Commercial goods or intended to be sold or leased
- Alcohol and alcoholic beverages; Tobacco products; Firearms and weapons; Explosives, fireworks and ammunition; Food, plants and animals; Vehicles; Endangered species; Regulated health products (medication); Currency and monetary instruments.
- Prohibited goods, Cultural property, used or second hand mattress.

## Importing a Vehicle into Canada

### WHO

---

- Any resident or non-resident individual may import a vehicle to Canada under specific regulations.

### WHAT

---

- Antique reproduction vehicle, bus, chassis-cab, low speed vehicle, motorcycle, multi-purpose passenger vehicle (some examples are motor home, van, minivan, 4X4, and jeep), passenger car, limousine, restricted use motorcycle, electric bicycle, snowmobile, snowmobile cutter, trailer (some examples are utility, horse, boat, car dollies), trailer with equipment mounted on it, trailer converter dolly, truck.
- Must qualify for importation under Transport Canada's Registrar of Imported Vehicles (RIV) program.

### REQUIRED DOCUMENTS

---

- Original Certificate of Title OR grey card
- Photocopy of a valid passport

### RESTRICTIONS

---

- **Transport Canada requirements are complex and you should confirm vehicle admissibility BEFORE you proceed!**

## Restricted goods

- **Alcoholic Products**
  - Must respect minimum legal ages under the laws of the importing province or territory.
  - Must accompany the traveler on arrival in Canada
  
- **Tobacco Products**
  - Must respect minimum legal ages under the laws of the importing province or territory.
  - A minimum duty applies to tobacco products if it is not marked "**CANADA – DUTY PAID • DROIT ACQUITTÉ**"
  - Must accompany the traveler on arrival in Canada
  
- **Health Products (drugs & medication)**
  - Restricted under Health Canada
  
- **Currency and monetary instruments**
  - If equal to or greater than CAN \$10,000 **MUST** be reported to the Canadian Customs authorities.
  
- **Firearms and weapons**
  - Restricted under Canadian Foreign Affairs.
  
- **Explosives fireworks and ammunition**
  - Restricted under Canadian authorities.
  
- **Food, plants and animals**
  - Restricted under Canadian Food Inspection Agency.
  
- **Endangered Species**
  - Carefully controlled under the *Convention on International Trade in Endangered Species of Wild Fauna and Flora* (CITES).
  
- **Prohibited goods**
  - Certain goods are prohibited and cannot be imported such as obscene materials; hate propaganda and child pornography into Canada.
  
- **Vehicles**
  - Restricted under Transport Canada, Canadian Food Inspection Agency and Canada Border Services Agency.
